4.1 Sector name changes (verbal update provided for information): FTSE Russell informed the advisory committee that the FTSE Nareit Timber REITs sector would be renamed to FTSE Nareit Timberland REITs and the FTSE Nareit Infrastructure sector would be renamed to FTSE Nareit Telecommunications REITs to

better reflect the segment of the market. FTSE Russell added that a technical notice would be released in due course with the changes becoming effective in Q4 2024. There were no comments.
